Town of Berlin Historic District Commission December 1, 2021

Chairman Carol Rose called the December 1st, 2021, meeting for the Historic District Commission to order at 5:30PM. Members present were Carol Rose, Mary Moore, Robert Poli, Norman Bunting and John Holloway. Members absent from meeting was Mrs. Laura Stearns. Staff Members present were Planning Director Dave Engelhart and Permit Coordinator Carolyn Duffy.

Chairman Carol Rose called for a motion to adopt the December 1, 2021, Mr. Norman Bunting asked if they could hear 24 Broad Street application for the signage first. Chairman Rose asked the other board members if they were ok with the change. They all agreed with the changing of order. Chairman Rose accepted the motion as amended. Mr. Norman Bunting made the motion to hear 24 Broad Street for signage in front of 16 Pitt Street. Mr. Robert Poli seconded the motion, and it was unanimously accepted by the commission. Chairman Carol Rose asked if there were any additions or corrections to the November 3rd, 2021, minutes. Mr. John Holloway stated he had made mention to the correction to his name to Carolyn. Chairman Carol Rose made motion to accept the minutes as corrected. Mr. Robert Poli -made the motion to approve the minutes. Mr. Norman Bunting seconded the motion, and it was unanimously accepted by the commission.

Chairman Carol Rose called Case # 12-1-21-26, Mr. Ernest Gerardi for 24 Broad Street. Chairman Carol Rose stated Mr. Gerardi was representing for 24 Broad Street and had brought the sign they wanted to put up. Chairman Rose stated the members have had time to review the signage. She than asked Mr. John Holloway if he was ok with the sign. Mr. Holloway replied he was ok with the signage. Mr. Robert Poli, Mr. Norman Bunting and Mrs. Mary Moore were all ok with the signage. Chairman Rose called for a motion to approve. Mr. Robert Poli made the motion to approve Case # 12-1-21-26 for signage. Mrs. Mary Moore seconded the motion, and it was unanimously accepted by the commission.

Chairman Carol Rose called Case # 12-1-21-25 for 16 Pitts Street new renderings for the 410 Social. The new owners for the 410 Social were present. Chairman Rose asked them to give their names Marcos Lopez and Brandon Tull. She then asked them what their dream was for the inside. Mr. Marcos Lopez stated for the interior they wanted to keep the same format with one wall separation more tables, the bar to remain where its located. They want to create a family friendly atmosphere hoping to brighten the place up a bit. Chairman Rose asked if they were going with a Maryland Sports theme. He stated they wanted to be part of the community and to create something to make Berlin excited about. The feel is more like a cornerstone in Berlin not on Main Street. He stated there is so much more to Berlin. He stated they have two silent partners. This is home to them and want to make the town proud. Berlin has a lot of people that want to maintain the integrity of the town and its charm.

Chairman Carol Rose asked Mr. Norman Bunting to start with his comments. Mr. Norman Bunting stated he loved it. They have been looking at a lot of renderings, but he really likes this a lot. He stated this is what I have been looking for. The three-tier drop will remain the same just wanted that on the record. The recess lighting and the black awning and the dark gray he

loved it. The signage on the corner he said he loved it. Thought it was a very good rendering and hope the others agreed. Mrs. Mary Moore stated she liked it too and the signage. She stated most of the traffic coming to town would come on William Street and she stated this blends in with the town. Mr. John Holloway said he really liked it too. He asked if they were able to run the duct work to the back side and through the ceiling. Mr. Brandon Tull replied there should be no issue with them moving the vents. Mr. Holloway stated this look preserves the look of the building. Mr. Robert Poli said he liked it too. He stated it really helps to restore the historical nature of the town. He liked the contrast with the colors and the windows will blend. The transom look fits with what is on Main Street. He asked if they would be removing the brick and putting stucco. Mrs. Samantha Pielstick said she talked with Mr. Jack Burbage, and they will be able to put the stucco over it.

Mr. Bunting asked about the signage. Mr. Marco Lopez stated the sign would be about 4 feet in diameter. The thickness would be about a foot you would only see the lighting through the numbers. Planning Director Dave Engelhart stated it would be similar to the Blacksmiths sign. Chairman Carol Rose asked about the material for the sign. Mr. Lopez said it would be acrylic he thought. Mr. Engelhart read what it said it would be aluminum with white acrylic face and black vinyl logo overlay mounted to the building. Chairman Rose asked that they put what they say they are going to put there. Mr. Bunting asked about the name 410 Social being on the window. Mr. Lopez stated they were putting the lettering on the inside of the window. Mr. Engelhart told them they looked like they were good for the signage. They would come to Planning & Zoning for the sign permit. Chairman Rose went back over the list from the last meeting. The cornices will remain, all existing stucco is to be repaired and matched as close as possible, all windows remain as is, the awning will be on Pitts Street and angled, same exit doors just different size, charcoal color, off white color, the awning will have a factory finish in black, casing in white. Mr. Bunting asked for a strong recommendation for the other building to be painted. Mr. Bunting asked Mr. Poli to list the recessed lighting and that the three-tier roof line is to remain.

Chairman Carol Rose called for a motion. Mr. Robert Poli made motion to approve Case # 12-1-21-25 as follows that the white brick will be covered with stucco, signage mounted on corner of building, logo 410 Social on interior of windows, charcoal color black, antique white in color, black metal awning, recessed lighting on Pitts and William Street also including the list from last months meeting. Mr. Norman Bunting seconded the motion, and it was unanimously accepted by the commission.

Chairman Carol Rose called for comments from the public. No comments from the public. Mr. Engelhart told Mr. Poli that he and Ms. Mary Bohlen had been discussing the 95 links on the thumb drive and it could not be put on the web page due to the size of it. They are going to link it to the webpage, but first making sure the facts are correct. The best idea was to review it compress it down and then link it to the source. Mr. Bunting stated they had started painting the Pitts house. Chairman Carol Rose called for a motion to adjourn. Mr. John Holloway made the motion to adjourn. Mrs. Mary Moore seconded the motion. Meeting adjourned 6:30PM
